Article 44, Paragraph 1, Subparagraph 1 of the *Regulations Governing Accreditation of Teacher Qualifications at Junior Colleges and Institutions of Higher Education* stipulates that if any co-author's certification is confirmed by the Ministry of Education to contain false information, the applicant shall be unqualified with no further applications accepted for 1 to 3 years. Paragraph 1, Subparagraph 3 stipulates that if any co-author's certification is confirmed by the Ministry to have been forged or altered, the applicant shall be unqualified with no further applications accepted for 7 to 10 years.
- 4. If the co-author is a foreigner, this form shall be written in English (for full understanding of contents and purpose).
- 5. Co-authored works can only be submitted for review as the representative work of one applicant; all other co-authors must renounce their right accordingly.
- 6. Contents that do not fit within the columns may be displayed in a separate attachment.
